

# The Needle Syringe Program

• Aims: to reduce the transmission of BBVs among PWIDs.

# **HIV Prevention**


- Early adoption of NSP across Australia (bipartisan political approach in 1988)
- Increased investment in and accessibility of NSP
- High rates of testing



From 2000-2009 there has been 32,050 cases of HIV prevented

# **Hep C Prevention**

- Steady decline in new infections since 2003:
  - About 90% of new Hep C infections are transmitted through shared injecting equipment
  - Increased investment in the NSP
  - Increased access to drug treatment

NSPs are Australia's most successful strategy for preventing BBV transmission among PWID

## Global availability of NSP in the Community and in prisons

Among 158 countries and territories:

- 93 support harm reduction in policy or practice
- 90 have NSP
- 8 have NSP in prisons

NSP available in the community NSP available in the community & prison NSP not available

# Global availability of opioid substitution therapy in the community and in prisons

Among 158 countries and territories:

- 80 have OST programs
- 52 have OST in prisons
- 10 have drug consumption rooms

# Australian results: NSP




Financial: an outlay of \$243 million on NSP initiatives resulted in a net financial cost saving of \$1.03 billion

### Quantity and quality of life benefits by 2010:

- an estimated 650 fewer people living with cirrhosis
- 90 hepatitis C-related deaths will have been prevented
- 4500 AIDS-related deaths will have been prevented




## Pharmacies 15% of distribution



#### NSW PHARMACY NEEDLE AND SYRINGE PROGRAM PARTICIPANT INFORMATION STATEMENT

The Needle and Syringe Program is an evidence-based public health program, which aims to minimise the transmission of blood borne viruses amongst people who inject drugs.

Pharmacy Needle and Springe Program (PKBP) outlists are key combuton to Australia's network of Needle and Springe Program services, with community pharmacies representing over 50% of the needle and springe program outlists located in the community. The conversity pharmacy network is well placed to provide assistance in the distribution of stelle injecting equationers, advice and referand to networks revises.

The PNSP is fully funded by the NSW Ministry of Health and is administered by The Pharmacy Guild of Australia (NSW Branch).

#### **NSW PHARMACY FITPACK SCHEME**

Participation in the NSW Pharmacy Fitpack Scheme includes the following activities:

- The provision of Fitpacks\* through sale or exchange to members of the public;
- The provision of other itmes of injecting equipment where requested and available;
- Provide access to a sharps disposal service to the community for the safe collection and return of Fitpacks<sup>1</sup>;
- Contribute to the provision of educational information to people who inject drugs for the purpose of minimise the transmission of blood borne virus infections.

#### **PROGRAM INCENTIVES**

Participating program pharmacies may be eligible to receive the following program incentives, subject to satisfactorily meeting program requirements.

#### Program Participation - New NSP

Community pharmacies which are entering the Scheme may be eligible to receive a one-off introductory incentive upon registration. This program incentive is currently \$385 (GST Ind).

#### Fitpack\* Exchange - Program Incentive

Program incentive payments are provided for each Fitpack\* which has been exchanged by a participating program pharmacy. Further details on the Fitpack\* exchange can be found in the program manual.

#### **PROGRAM PARTICIPATION - CONDITIONS**

Community pharmacies who participate in the Pharmacy Needle and Syringe Program agree to to the following program terms and conditions.

- The pharmacy acknowledges that its nominated representative and/or pharmacy staff have read the 'Participant Information Statement' and Program Manual, which explain the aims and objectives of the Pharmacy Needle and Syringe Program (PMSP).
- The pharmacy agrees to establish and maintain the professional services in accordance with the policies and procedures outlined in the Program Manual.
- It is understood that the pharmacy can withdraw from the program at any time without any prejudice to its relationship with the Pharmacy Guild of Australia (NSW Branch).
- 4. The pharmacy understands that eligibility to receive incentive payments as part of the program is subject to reporting against the set outcomes as determined in the program guidelines. This includes the satisfactory completion and provision of program documentation (6: Fitack\* Exchance Locd).
- 5. The pharmacy's details will be publically listed as a participating pharmacy of the Program. The pharmacy also agrees that the disclosure of information pertaining to the pharmacy's involvement in the Program will be provided to the NSW Minimir of Health.
- 6. The pharmacy agrees that the information provided as part of the program will be used to prepare reports availating the outcomes against its set aims and objectives. It is also understood that these reports will be provided to the NSW Mirestry of Health and other key stateholders as required for research and evaluation purposes.
