

### **Membership Payment Options**

Your membership subscription for the year 2024 – 2025 is due for payment in full by 1 July 2024 for your membership to remain financial.

We have 3 membership subscription payment options you can choose from. Payments by Electronic Funds Transfer are acceptable, our bank details are on your invoice.

Please note that non-payment of the subscription fee by the due date(s) may result in the suspension of your membership until the subscription amount has been paid in full unless prior arrangement with the Branch has been made.

## Option 1. Annual payment \$2860

Payment in full by 1 July 2024.

# Option 2. Payment by equal Direct Debit quarterly instalments of \$715.00

The direct debit payment option allows you to pay your current subscription fees in quarterly payments paid in advance.
