

Payment Options

Option 1. Lump sum payment

If you pay your subscription fee as a lump sum, payment must be received by **31 July 2026**. Please note that non-payment of the subscription fee in full by the due date(s) may result in the suspension of your membership rights and privileges until the subscription amount has been paid in full, unless prior arrangement with the Branch has been made. Please refer to the invoice for payment methods.

Option 2. Direct Debit (Quarterly) – please fill in Direct Debit Request Form enclosed

The direct debit payment option allows members to pay their current subscription fees in 4 equal quarterly payments, commencing in June and concluding in March of each financial year. This option is available either by debit or credit card.

Quarterly Direct Debit

Payment will be debited on the following dates:

- 3rd payment: *28 December 2026* **\$825.00**

Option 3. Direct Debit (Monthly) – please fill in Direct Debit Request Form enclosed

The direct debit payment option allows you to pay your current subscription fees in 12 equal monthly payments, commencing in June and concluding in May of each financial year. This option is available either by debit or credit card.

Option 4. Direct Debit (Half Yearly) – please fill in Direct Debit Request Form enclosed

The direct debit payment option allows members to pay their current subscription fees in 2 equal half-yearly payments, commencing in July and concluding in December of each financial year. This option is available either by debit or credit card.

You only need to sign up once – there is no need to reapply each financial year, provided there are no changes to your bank account or credit card details. A new Direct Debit Request Form will need to be completed. To cancel your direct debit arrangement, written authority is also required **at least 14 days** prior to the next debit date.
